RE: Dealer information about the MICHELIN Pilot Sport Cup 2 R

With this letter we are informing you about the special product characteristics of this semi-slick tyre with the suffix 'R'. This information is to be understood as complementing the general instructions for using the Pilot Sport Cup 2 and ensures that this tyre is used in a way that suits the specific product.

Supplementary instructions on how to use the MICHELIN Pilot Sport Cup 2 R:

The MICHELIN Pilot Sport Cup 2 R is designed as a racing tyre (semi-slick) for extreme performance on a dry race track and is optimised specifically for use on a dry race track. As with all semi-slicks, there is a tendency for aquaplaning on wet race tracks or road surfaces, especially towards the end of their useful life. In wet conditions, you should therefore drive particularly carefully, with reduced weight and with safety systems and driving assistance systems activated.

The tyre satisfies the statutory regulations for use on public roads and motorways in the areas in which it is distributed. It complies with all the necessary specifications and regulations and has the required markings. To ensure the best possible handling on race tracks and roads, a complete set of four MICHELIN PILOT SPORT CUP 2 R tyres should always be fitted.

As a special tyre for extremely dry conditions whose technologies were developed in the motorsport sector, the MICHELIN PILOT SPORT CUP 2 R requires a warm-up phase just like in motor racing in order to ensure optimum performance.

The special technical features of the MICHELIN Pilot Sport Cup 2 R outlined above result in special conditions for you.

As a dealer you are responsible for marketing the product in a way that meets the requirement notified in this letter by making your customers aware of the special technical features of the MICHELIN Pilot Sport Cup 2 R which are outlined in this letter and the product-specific use that is required as a result in order to provide the greatest possible level of safety.

In this context, you as a dealer have an **obligation to inform** which must be documented by you if possible.

Feel free to hand over the customer letter which we have prepared for this purpose and the "Michelin informs" disclaimer leaflet when selling the MICHELIN Pilot Sport Cup 2 R and get the customer to acknowledge that they have received this. However, you are also free to provide proof of notification with some other suitable form of documentation.
