



### **MICHELIN TYRES DAMAGE COVERAGE CAMPAIGN TERMS & CONDITIONS**

- The offer is only applicable on 18" in above sizes.
- Tires that are covered under this "Accidental Warranty" will also be covered under MICHELIN Tire Limited Warranty. Terms and Conditions apply, for more details, please ask your Service Advisor.
- If the customer intentionally sabotages the tyre, then the guarantee is fully void, and the customer has no right to claim any compensation.
- The accidental damage cover/warranty is void if the original tyre sizes & specifications are not followed or when any changes are made to the vehicle.
- Only Michelin's Authorized Importers in the UAE has the right to decide the repair or replacement of tyres and the customer has no right to claim other than tyres validity of use.
- This damage cover is valid for one year from the date of purchase and is not renewable.
- The customer has no right to demand repair or replacement of the tyre unless he presents the original invoice.
- In case of non-availability of original tyre, Michelin's Authorized Importers in the UAE has the right to decide on customer's compensation; repair and replacement depends on the condition of the tyre.
- Damage cover is applicable only in United Arab Emirates
- Accidental damage cover includes collision of the tyre with rigid objects on the road or potholes that cannot be repaired.
- Michelin's Authorized Importers in the UAE is committed to repair or replace the tyre with the same quality and in the same specification provided in case available.
- The warranty is canceled in the following cases and shall be considered void (commercial vehicles, natural disasters, intentional sabotage, failure of tires outside United Arab Emirates, track usage, driving on unpaved roads, tires that do not meet factory specifications, excess load, heat, continuous operation and excessive consumption, tire damage due to modifications to the vehicle or vehicle mechanical irregularities, tyre noise ,loss, theft, personal injury or death, improper maintenance such as unbalanced tires, non-periodic rotation, and not maintaining the right inflation pressure). This contract covers only the warranty of tires that are damaged due to contact with road hazards.
- The damage cover shall be canceled if the tyre is replaced or repaired outside United Arab Emirates
- To avail the accidental cover benefits, it is mandatory maintain correct air pressure as recommended by the manufacturer.
- The damage cover is not transferable to another person or vehicle.
- Without the original invoice & the warranty document, the warranty is void.
- Michelin's Authorized Importers in the UAE has complete authority to consider this agreement and the policy as void; with no refund, in case of any fraudulent acts.
- The Michelin damage warranty can be claimed by consumers only once.
- Michelin's Authorized Importers in the UAE reserves the right and absolute discretion to vary, delete, or add any of the terms and conditions, the product prices and eligibility during the campaign period depending on the stock availability only after informing and taking approval from Ministry of Industry, Commerce & Tourism.
- Michelin's Authorized Importers in the UAE is entitled to terminate the "Accidental Warranty" campaign program without any prior notice.
